Performance Dates and Times:

- Thursday, November 21st at 9:30am and 11:30am
- Friday, November 22nd at 9:30am

Ticket Prices:

- Student Tickets: \$10
- One teacher and one para-pro per class attend free of charge (total of 2).
- Additional adult/chaperone tickets: \$10 each (include these numbers in your reservation).
- Homeschool/co-op groups may have one adult chaperone per 10 children at no additional cost; otherwise, all adults must purchase a ticket (include these numbers in your reservation).

Important Details:

- All individual's funds must be collected by the school/co-op groups.
- No walk-up tickets are available for these performances.

Reservation Process:

Completion of the reservation form is required but does not guarantee your reservation. The Matinee Coordinator uses the information provided to create an invoice for your group. Once payment is received, our Matinee Coordinator will email your field trip coordinator a receipt, reservation confirmation, arrival/parking instructions, and our Nutcracker Lesson Plan. Bookings and reservations are based on seat availability.

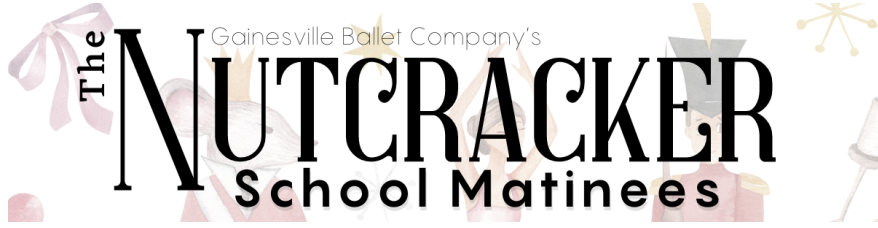
